IMPLEMENTATION SUPPORT AGENCIES UNDER JJM

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the number of implementation support agencies empanelled under the Jal Jeevan Mission (JJM) throughout the country and the details thereof;
- (b) the details of the implementation support agencies empanelled, district-wise;
- (c) the criteria for empanelment of these agencies and details thereof; and
- (d) whether it is a requirement for the implementation support agencies to possess technical knowledge about water management and if so, the details thereof?

(a) & (b) The number of Implementation Support Agencies (ISAs) empanelled by States/UTs under Jal Jeevan Mission (JJM) is at **Annexure**. The ISAs are empanelled by the respective state/UT governments at the state level, and not at the district level.

(c) to (d) Under JJM, State Water and Sanitation Mission (SWSM) is entrusted with the responsibility to empanel partner Non-Government Organizations/ Voluntary Organizations/ Self Help Groups/ Community Based Organizations/ Trusts/ Foundations as Implementation Support Agencies (ISAs). District Water and Sanitation Mission (DWSM) engages ISAs from the ISAs empanelled by SWSM.

The Criteria for selection of Implementation Support Agencies (ISAs) is given at Annex-V of Operational Guidelines of Jal Jeevan Mission available in public domain at:
